APPLICATION FOR NOMINATION TO THE PARISH COUNCIL 2024-2025

TO BE A CANDIDATE FOR THE PARISH COUNCIL YOU MUST BE A MEMBER IN GOOD STANDING OF THE PARISH AS DEFINED BY ARTICLE 18 SECTION 1 OF THE UNIFORM PARISH REGULATIONS (2019) <u>http://www.goarch.org/documents/regulations</u> :

1. **SPIRITUALLY**: You must attend the Divine services and receive the Sacraments <u>regularly</u>; uphold the Teachings of the Church. You must participate in the Sacramental life of the Church, thereby setting an example for the Parish and work <u>in cooperation</u> with the Priest in order to fulfill the purpose of the Church. <u>This is certified by the Priest</u>. (UPR Art. 18, Sec. 1; Art. 25. Sec. 2)

2. **CANONICALLY**: You must live your life and activities in accordance with the faith and Canons of the Church. If you are married, you must have been married in the Orthodox Church. If you are divorced, you must have obtained an ecclesiastical divorce. In addition, no person shall be considered in good-standing if they are a member of a non-Orthodox faith or other religion. (see Article 18, Sec. 3) **This must be certified by the Priest.** (UPR Art. 18, Sec. 1; Art. 25. Sec. 2)

3. **FINANCIALLY:** You must be a Steward of the Parish for at least <u>one (1) year</u> immediately preceding the date of the elections. You must fully participate in stewardship <u>by submitting a pledge card</u> detailing your stewardship commitment and <u>being active</u> in the parish thereby setting an example for other parishioners. <u>This must be certified by the Priest.</u> (UPR Art. 18, Sec. 1; Art. 25. Sec. 2)

4. You must be willing to take the Affirmation of office without exception as administered by the Priest at the appropriate time and be willing to sign a form attesting to your Affirmation. In addition, each member or member-elect is obliged, without exception, to execute the Disclosure statement. Any person declining to execute the disclosure statement and/or the Affirmation of Office shall not be a member of the Parish Council. (UPR Art. 26, Sec. 4 A&B)

5. After appropriate discussion, you must be willing to support and cooperate with all majority decisions of the Parish Council. You must be willing to fulfill the Duties of a Parish Council member as contained in Art. 29, sec.1 of the UPR.

6. You must attend a <u>mandatory</u> seminar conducted by the priest prior to the election. At this seminar, the priest will discuss the Uniform Parish Regulations and the duties of a Parish Council Member. (UPR Art. 25, Sec. 3A) <u>Failure to attend will be cause for</u> <u>removal of your name from the ballot</u>. (UPR Art. 25, sec. 3D) A make-up seminar will be offered if your attendance at the seminar is impossible. At the conclusion of the seminar all candidates will acknowledge by signing a statement that they understand and will abide by the Uniform Parish Regulations (Art. 25, Sec. 3 D). This regional seminar is scheduled for Thursday, November 16 Monday, November 27, 2023, at Presentation of Christ in East Pittsburgh more details to follow.

7. You must register and complete a background check through Sterling Volunteers at youthsafetyplatform.goarch.org prior to submitting this application.
