About the Speaker: The Very Rev. Dr. Paul Nadim Tarazi, Th.D., is Professor of Old Testament at **St. Vladimir's Theological Seminary**, Crestwood, NY, where he teaches Old and New Testament and Biblical Hebrew. He also teaches at **Holy Cross Greek Orthodox School of Theology** in Brookline, Massachusetts and at **St. John of Damascus Institute** in Balamand, Lebanon.

His publications include commentaries on 1 Thessalonians and Galatians, multi-volume Introductions to both the Old & New Testaments, and many scholarly articles. Fr. Tarazi travels widely to speak about Scripture and related topics and has represented the Orthodox Church at ecumenical gatherings. He is known for his ability to hold an audience's interest with his dynamic presentation style. A past lecture series participant said: "Fr. Tarazi really teaches us Scripture, we don't just discuss it."
