► To be eligible to participate in the General Assembly you must be a member in good standing as defined in the Annunciation By-Laws. A Parishioner is considered to be in "Good Standing" when he/she meets his/her religious and moral duties as described in Section 1 of Article 18 of the Uniform Parish Regulations, is a minimum 18 years of age, is current in his or her stewardship and other financial obligations to the Parish fulfilling his/her annual pledges to the Parish according to the recommended guidelines adopted by the parish Assembly, and abides by all the Regulations and Parish Bylaws.

Any Parishioner who is current and not in arrears in his/her stewardship i.e. has made a good faith and reasonable effort to meet his/her financial obligation to the Parish (Note: At least 25% of the stewardship obligation must be paid by the time of the Spring General Assembly, and at least 75% by the Fall General Assembly) and the Parish Priest with the assistance of the Council Treasurer has determined that the Parishioner is in canonical and financial good standing as specified in Article 18, Sections 1 through 3 of the Uniform Parish Regulations, then he/she will be a "Parishioner in good standing".

► The financial statement will be available by May 16<sup>th</sup> for the eligible members. Please contact the Church Office or any Council Member for a copy prior to the General Assembly.
